MODIFICATION TO JAIL CONTRACT CITY OF WAPATO

This Modification to the Jail Contract ("Modification") by and between CITY OF WAPATO ("Wapato") and CITY OF GRANGER ("Granger") shall modify and amend the Jail Contract dated January 01, 2010.

RECITALS

- A. On or about January 01 2008, Wapato and Granger entered into a jail services agreement for the use and occupation of the Wapato City Jail.
- B. Daily bed rate for the year 2010 is \$45.00 a day, per bed.
- C. The parties, therefore, agree to modify the terms and conditions of the Jail Contract, dated January 01, 2010.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants contained below, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties to this Modification, the Parties agree as follows:

- 1. Section 3 shall be replaced as follows:

3. Compensation. Granger agrees to pay Wapato each month the sum of forty five dollars (\$45.00) per day for each Granger prisoner incarcerated in Wapato jail facilities pursuant to the terms of this Agreement. Any part of the day, beyond six (6) hours, shall be considered a full day. Payment shall be made for the first day of incarceration, but not for the last day of incarceration. The charges in this section shall apply without regard to whether the prisoner has been charged, tried, or sentenced and shall continue until Granger notifies Wapato that the prisoner is to be released or until the sentence has been served by the prisoner. The City of Wapato reserves the right to increase the daily rate each year, with the understanding that the contracted city will be given 60 days prior notification of said increase. The City of Wapato will be billing Granger eleven equal monthly payments of \$1369.00 and one month at \$1366.00 for the total of \$16,425.00.

- 2. Terms and Conditions. All of the terms and conditions of the Jail Contract dated January 01, 2009 shall remain the same, except the section noted in paragraph 1 of this Modification. Wapato will offer three inmate workers on a daily basis to work in the City of Granger.




1. The City Council authorizes the modified interlocal agreement between the city of Granger and the City of Wapato to be signed by the Mayor.
