This Amendment is made by the state of Washington, Department of Corrections, hereinafter referred to as Department, and the City of Wapato, hereinafter referred to as the City, for the purpose of amending the above-referenced Interagency Agreement, heretofore entered into between the Department and the City.

WHEREAS the purpose of this contract amendment is to adjust the per diem rate and extend the period of performance;

NOW THEREFORE, in consideration of the terms and conditions contained herein, or attached and incorporated and made a part hereof, the Department and City agree as follows:

Section 2.01 Term is amended as follows:

The term of this Agreement shall begin October 1, 2007 and continue through December 31, ~~((2009))~~ 2010.

Section 3.10 Billing is amended as follows:

The base rate will be ~~((\$40))~~ ~~((\$45.00 as of January 2008))~~ \$50 per day per offender. Billing will occur monthly for the actual bed days used in the preceding month.

Additions to this text are shown by underline and deletions by ~~((strikeout))~~. All other terms and conditions remain in full force and effect. The effective date of this amendment is January 1, 2010.

WHEREAS, Washington State Department of Corrections has need for usage of the jail facilities maintained by the City; and


WHEREAS, the agreement with the state will be fulfilled in accordance to the signed inter-local agreement between the City of Wapato and the state; and


1. The City Council authorizes the interlocal agreement between the Washington State Department of Corrections and the City of Wapato to be signed by the Mayor.
